The new revised 2018 GSF Care Homes Programme is now:-

1. **Updated** - in line with current best practice including new resources
2. **Shorter** - 3½ days over 6 months
3. **Simpler** - more focussed with 7 key tasks leading to Accreditation
4. **Cost effective** - reduced cost reflecting fewer training days enabling greater uptake
5. **Outcome focussed** - evidence of audits, outcomes, systematic care useful for CQC
6. **Digital-ready** - helps get you ready for better IT record sharing to meet 21st C needs
7. **Locally delivered** - through GSF Regional Training Centres

Care homes have become one of the mainstays of end of life care outside hospitals and are key providers of person-centred care for a large proportion of people nearing the end of their lives, particularly the elderly and those with frailty and dementia. In fact, some predict that care homes may replace hospitals soon as the most common place for people to die. They have a significant impact on hospital services - half of all care home residents' admissions to hospital could be avoided if staff in care homes were better trained (National Audit Office 2008). This would enable more people to live and die more peacefully where they choose, whilst reducing hospital admissions.



GSF has been part of a national momentum of best practice since 2004. GSF is the most widely used end of life care improvement programme for frontline staff with every GP Practice (basic level) over 3,000 care homes GSF trained, hundreds accredited and many reaccredited 2 or 3 times. GSF is regarded as a kitemark for quality.

GSF training and accreditation ensures systematic proactive, person-centred end of life care, improving patient experiences, coordination and patient flow across boundaries of care, cost-effectiveness and improved outcomes.

GSF empowers care home staff to engage in more productive working relationships with GPs and other health and social care professionals. *It is about putting national policy into practice at grass roots.*

GSF involves 3 simple steps


1. **Identify** - Recognise decline early, code all residents related to their identified needs
2. **Assess** - all residents clinically and personally with Advance Care Planning discussions
3. **Plan** - Enable all residents to live well and die well in the place of their choosing, reducing unnecessary hospital admissions and improving communication with GPs, hospitals and others.

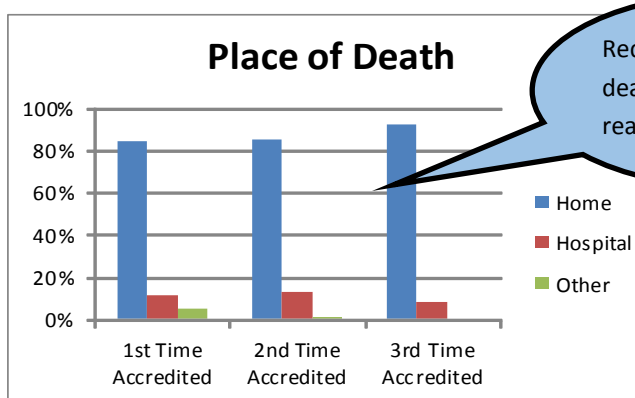
